Quick Start Checklist for First-Time Visitors

Preparing for your first visit can feel overwhelming, but following this comprehensive checklist will help ensure a smooth experience. Each step is important, and missing even one can result in delays or denied entry. Take your time to complete each requirement carefully.

Complete Visitation Application

Submit a complete visitation application with a properly sized photo and all required documents. Critical: Photo must fit exact parameters specified or entire application will be rejected. Applications must be renewed every two years.

Confirm Approval Status

Wait for confirmation that you've been approved to visit. Processing times vary, so apply well in advance of when you hope to visit.

Schedule Your Visit

Call the facility directly to schedule your visit. Visits are appointment-only and must be arranged in advance.

Review Facility Requirements

Carefully review the facility's specific visitation hours, dress code requirements, and any special policies that may apply.

Plan Your Arrival

Plan to arrive at least 30 minutes early to allow time for security procedures, but not more than 30 minutes before your scheduled visit time.

Prepare Required Items

Bring a valid government-issued photo ID. Leave all personal items, electronics, and prohibited items at home or in your vehicle.

Dress Appropriately

Wear clothing that strictly adheres to the dress code. Violations can result in denied entry with no exceptions.

Prepare for Security Screening

Know that you will be required to undergo a full-body scan similar to airport security procedures.

Practice Patience

Be prepared for potential delays. The process can take time, and unexpected situations may arise.

Helpful Insights from FRC Guests

These practical tips come directly from families who have successfully navigated the visitation process. Their real-world experiences provide invaluable guidance that goes beyond official policies to help you prepare for the realities of visiting an incarcerated loved one.

Application & Scheduling

- **Visitation applications** must include a current photo that meets exact size specifications. For minors, include a birth certificate. Children ages 6 and older must have a photo attached. Remember to renew every two years.
- **Scheduling visits:** Contact the facility directly by phone. All visits are appointment-only with no walk-ins accepted.
- **What to bring:** Government-issued ID is mandatory. Absolutely no contraband or electronic devices of any kind.
- **Arrival tips:** Arrive early to allow time for processing, but not more than 30 minutes before your scheduled visit time.

During Your Visit

- **Dress code matters:** Violations can result in immediate denied entry with no exceptions or second chances.
- **Snacks during visitation:** Purchase a reloadable card for vending machines in the lobby. Only one card is issued per visitor. Bring \$5 or \$10 bills (cash only) to load money onto the card before going through security.
- **Stay informed:** Always verify any information directly with the facility, as policies can change.
- **Lean on others:** Connecting with other families through support groups can offer both emotional support and practical advice from those who understand your journey.

Dress Code Guidelines

Adhering to the dress code is absolutely essential for a successful visit. Violations will result in denied entry, and there are no exceptions. When in doubt, choose more conservative clothing options. Many experienced visitors recommend bringing a backup outfit in your car just in case.

✓ Do Wear

- Modest clothing that covers shoulders and knees completely
- Closed-toe shoes with no exposed toes or heels
- Appropriate undergarments (required)
- Conservative, solid-colored clothing
- Clothing that fits properly without being tight or revealing

X Do NOT Wear

- See-through clothing or underwire bras
- Spandex, yoga pants, or tight-fitting clothes
- Camouflage prints or white clothing
- Sleeveless tops, crop tops, or low-cut shirts
- Flip-flops, slides, or steel/composite toe shoes
- Excessive jewelry or accessories
- Clothing with holes, rips, or tears

Pro Tip: If you're unsure whether an outfit is appropriate, bring a backup outfit to leave in your vehicle. This simple precaution can save you from a wasted trip and the disappointment of being turned away at the door.

Conduct & Security Protocols

Understanding and respecting security protocols is crucial for maintaining your visitation privileges and ensuring the safety of everyone in the facility. These rules exist to protect both visitors and incarcerated individuals, and violations can have serious consequences.

Respectful Behavior

Treat all correctional staff, other visitors, and incarcerated individuals with respect and courtesy at all times. Disrespectful behavior can result in immediate termination of your visit and potential loss of visitation privileges.

Physical Contact Limits

Physical contact between visitors and incarcerated individuals is strictly limited and continuously monitored. Typically, a brief embrace at the beginning and end of the visit is permitted, but policies vary by facility.

Security Screening

All visitors are subject to metal detectors, full-body scans, and health screenings. These procedures are mandatory and non-negotiable for entry into the facility.

Prohibited Items

Strictly prohibited items include tobacco products, electronic devices, unauthorized medications, weapons of any kind, and any items not explicitly approved by facility policy.

Contraband Violations

Attempting to bring contraband into a facility may lead to criminal prosecution and permanent revocation of visitation rights. Take this seriously and never attempt to bring prohibited items.

What If Plans Change?







Contact Facility Immediately

If you need to cancel or reschedule your visit, contact the facility as soon as possible. Providing advance notice is courteous and may help you reschedule more quickly.

Rescheduling Limitations

Missed visits may not be rescheduled immediately. Facilities have limited visitation slots, and you may need to wait for the next available appointment.

Unexpected Suspensions

In cases of facility lockdown, security incidents, or health concerns, visits may be suspended without advance notice. Stay flexible and patient during these situations.

Flexibility and understanding are essential when dealing with the correctional system. Unexpected changes can happen, and maintaining a positive attitude will help you navigate these challenges more effectively. Always have a backup plan and stay in communication with the facility.
